


FEMA 100 Year Floodplain Adopted 9/14/07



The FEMA Flood 100 year floodplain data was provided by the Department of Homeland Security - Federal Emergency Management Agency.

The final FEMA Flood Mapping data was adopted by Frederick County on September 14, 2007. The final proof flood data product was adopted through the Frederick County Zoning Ordinance Text Amendment ZT-07-11. The data is considered current until updates are received from FEMA.
